Expression of Interest for Delivery of Covid-19 Community Pharmacy Vaccination Service

Dear Pharmacist,

As the HSE expects vaccine supply to become more available in the coming months, it is preparing to expand the number of locations from which a COVID-19 Vaccination service can be delivered to include suitable community pharmacy locations. The vaccine currently expected to be made available through community pharmacy is COVID-19 Vaccine AstraZeneca®.

In preparation for the rollout, Pharmacists should conduct a risk assessment and capacity assessment to determine if their site is appropriate (premises and staffing levels) for the administration of the COVID-19 vaccines and to determine the number of vaccinations that they can administer safely. The HSE is finalising operational guidance including a checklist to assist with this process. It will be published shortly on the HSE website.

The HSE recognises that due to the space and staffing requirements of the service not all pharmacy locations will necessarily wish to deliver the service or be in a position to do so. Some pharmacy contractors may consider vaccination off site. In order to provide the COVID-19 vaccines in a safe and efficient manner, community pharmacies will require the following:

- Registration/Reception area for patients sufficient to allow for social distancing
- Vaccine preparation area and refrigeration area
- Vaccination area for patients
- Post vaccination area for patients which allows for patients to wait for the required 15minutes observation time after administration of the vaccine. This need not be within the community pharmacy building but must allow for social distancing and be supervised by pharmacy staff.

The objective of this communication is to elicit Expressions of Interest from pharmacy contractor locations who wish and are in a position to deliver a COVID-19 vaccination service in their locality.

In their review of any Expressions of Interest received, the HSE has to consider a range of factors from its own perspective, to include but not limited to efficiencies of delivery logistics and stock risk through wastage.

If you wish to deliver the service for this campaign, please complete the form attached and return for the attention of your local HSE Pharmacist by Monday 12th April 2021. A list of the respective names and contact details is included. Collated details of Expression of Interest will then be forwarded to PCRS, who will in turn advise you if your pharmacy can be included in the initial Community Pharmacy vaccine rollout. Please do not return the EOI form until after you have reviewed the HSE Operational Guidance for Vaccination in Community Pharmacy which will be published shortly.

The form can be signed by the Supervising Pharmacist where authorised by the Pharmacy Contractor to do so. Separate confirmations are required from the Superintendent Pharmacists. Please note the required confirmations are required before the pharmacy can be added to the list of locations to which the vaccine can be delivered.
